DESCRIPTION:

5-HTP (5-Hydroxytryptophan) is a substance produced in the body after eating foods that contain the amino acid L-tryptophan. The body uses 5-HTP to produce serotonin, an important neurotransmitter required for healthy nerve and brain function. Since it is closely linked to mood and relaxation, normal levels of serotonin allow for balanced moods and healthy sleep patterns.

Recommended Daily Allowance: N/A

Food Sources: Not found in foods to any appreciable extent (turkey, chicken, pork and cheese are good sources of tryptophan).

Causes of Deficiency: Serotonin deficiencies are often caused by excess stress and poor diet.

Symptoms of Deficiency: Serotonin deficiencies are linked to depression, anxiety, sleep disorders, obesity and addiction.

Complementary Nutrients: Carbohydrates trigger the production of serotonin. Vitamin B6 is also a critical nutrient for serotonin production. 5-HTP works in conjunction with Nature's Harmony® Relora® to further combat carbohydrate and sugar cravings.

HOW IT WORKS:

The transmission of signals through different regions of the brain is via chemical messengers called neurotransmitters, such as serotonin. But for many people, poor diet combined with the stress of everyday life has resulted in serotonin deficiencies. 5-HTP can help re-establish normal serotonin levels in the brain because it acts as a precursor to serotonin production in the body.

RESEARCH:

Clinical studies have shown that supplementing with 5-HTP can help improve mood and relaxation by normalizing serotonin levels in the brain.

SIDE EFFECTS:

Side effects from 5-HTP are rare, typically mild and may include upset stomach and drowsiness. If side effects occur, they usually disappear within a few days.
